
Important dates:

By June 2018, her expectations were exceeded thanks to the generosity of her customers and she raised enough money for 3 bursaries/scholarships to deserving students for their post secondary studies. Why does COBSS charge an administration fee for each award?

Our slogan, "we do the work, you get the credit" is easily understood when you trace the path your award takes from initiation through disbursement:

- Your donor contract must be drafted and signed, then entered into the accounting system, the database of awards, and the student application system. All monies received must be receipted correctly following the CRA's guidelines for registered charities.
- Once your award recipient has been chosen a letter is written to the student and sent to their school. As the donor, you will also receive a confirmation letter along with a profile of the recipient.
- After the student enters post secondary, COBSS must verify that their chosen institution is acceptable under CRA rules and issue a cheque to the school for payment.
- COBSS monitors any unclaimed awards and contacts alternates if necessary.
- COBSS files a charity tax return with the CRA.
